

**MODE OF PAYMENT OF CONSULAR FEES
TO
THE EMBASSY OF BELGIUM IN NEW DELHI**

1. While applying *in person at the embassy* : in cash OR through UPI (QR CODE)

2. In *other cases* : by remittance or by scanning QR CODE

2.1 Remittance

The fee has to be transferred in INR

THE FULL FEE has to be credited to the embassy account.

The applicant has to pay **ALL THE CHARGES** :

- charges to obtain the transfer from the remitting bank
- the charges of the intermediate bank
- the clearing charges

THE REMITTING BANK SHALL USE THE FOLLOWING ROUTE FOR THE TRANSFER:

The remitting bank should send the message **via SWIFT** if making international transfer

The remitting bank should send the message **via IFSC CODE** if making transfer within India

through the following **CORRESPONDENT BANK**
