

## Visa D – FAMILY REUNION with NON-EU SPOUSE (art. 10&10bis)

### **Required documents:**

1. National passport into which a visa can be affixed and which is valid for more than 12 months
2. Completed and signed national Belgian visa application form with 1 recent color photograph (5x3cm) with white background glued on the application form [Welcome to VFS Global | vfglobal](#)
3. Copy of proof of payment of the contribution covering administrative costs. [Redevance | IBZ](#)
4. The document to choose the language in which you would like to be informed about the decision in your visa application [Choice of language](#)
5. Copy of the identity page of your passport

### **A) From Non-EU Spouse, residing in Belgium**

6. Copy of the residence permit (front + back)
7. Proof that the person being joined has sufficient accommodation: Copy of proof of ownership of a house/apartment or a registered copy of the rental contract.
8. Proof (at least six last months) that the person being joined has stable, regular and sufficient means of subsistence to meet his own needs and those of the members of his family and avoid them becoming a burden on the public authorities. 9. Proof that the health insurance (mutualiteit/mutualité) of the person being joined agrees to cover the risks in Belgium for the visa applicant.

OR:

Copy of private travel insurance of the visa applicant valid in Belgium and covering a minimum of 30.000€ medical costs for a minimum period of 3 months (This document does not have to be provided in case the spouse in Belgium can prove that you will be registered on his/her health insurance in Belgium). ### **B) From both spouses**

10. Proof of marriage: copy of marriage certificate

**C) From the visa applicant**

11. Copy of birth certificate

12. Copy of divorce certificate (in case of previous marriage)

13. Copy of death certificate of your previous spouse / partner (if any)

14. Medical certificate from our panel doctor(+1 copy) attesting that the applicant is not carrying any of the diseases which might endanger public health. [Certificat médical | IBZ](#)

15. Certificate attesting to the lack of any convictions for crimes or offences under common law (+1 copy). (National Police clearance certificate from passport office + Apostille from MEA)

**Remarks:**

1. The applicant has to submit his/her application by him/herself. **(All the documents issued by a government authority should be submitted in original)**

2. The applicant needs to do all legalizations of official documents before submitting the visa application.

3. Minimum age of both spouses must be 21 years old (18 years if marriage took place before the spouse came to Belgium).

4. Additional documents, even if not featured in the list above, may be required by the Embassy.

5. The administrative fee is non-refundable if the visa is denied.
